The Applicant (as principal or agent) further agrees NOT to sell, lease, loan or deliver possession of the registration information, or a copy thereof, or any portion thereof, in any form or format, to any person, organization or agency without first submitting a new application and receiving written authorization from the County of Sacramento Voter Registration and Elections Department to release such registration information.

### **WILLFUL VIOLATION OF THESE PROVISIONS IS A MISDEMEANOR (ELECTIONS CODE §18109).**

- Current voter file containing voters with active status for the County of Sacramento, or you may specify certain school/special district(s), cities or precincts or voters with inactive status. This file will contain:
  - First name / last name
  - Birth date and birth place
  - Permanent Vote by Mail voter status
  - Date last voted
  - Voting history for countywide elections from the last 5 statewide elections
  - Residence and mailing address
  - Telephone number
  - Political Party
  - Precinct number / group
  - Date of registration
  - Email address
- A Vote by Mail file is available for the current election.

Precinct-by-precinct Statements of Votes Cast for the 2004 thru the most recent Elections are available electronically. Earlier precinct-by-precinct Statements of Votes Cast are available in paper copies.
- Digital Maps are available at [www.elections.saccounty.net](http://www.elections.saccounty.net), in PDF format on CD-ROM or FTP up/download. Due to size limits, they are not available via email.

### Permissive and Non-Permissive Access to Voter Registration

*Election Code § 2187, 2188, 2194; Government Code § 6254.4*

Persons who have access to **ALL VOTER INFORMATION** include those who are using the information for the following:

- **ELECTION PURPOSES:** Voter registration information must be made available to any candidate, any committee and to any person who communicates with voters in connection with any election. For example: persons, who in connection with a specific candidate or campaign, who run a phone bank, or walk precincts, etc.
- **SCHOLARLY PURPOSES:** Students working on a thesis, professors researching voting patterns and other academics involved in research.
- **JOURNALISTIC PURPOSES:** Members of the media are permitted access.
- **POLITICAL PURPOSES:** For example: persons who communicate with voters concerning legislation, vendors who provide information only to candidates, ballot measure committees, political parties and persons or organizations communicating with the voters about political issues whether or not this use is in conjunction with a specific election.
- **GOVERNMENTAL PURPOSES:** For example: the Jury Commissioner, District Attorney, Public Defender or other public government agency.
