What offices can I run for?

Prior to each election cycle, our office will post on our website the positions that are up for election. This is your opportunity to review which office you are interested in running for. Jurisdictions include:

What are some of the Qualifications?

- United States Citizen
- At least 18 years of age
- A registered voter living within the district in which they wish to represent at the time of appointment

Candidate Nomination Period

- The nomination period is when candidates can obtain the necessary paperwork to officially run for an office. Candidates must obtain and complete official nomination documents that are issued at our office. The nomination period is between 113 days to 88 days prior to the election.
- Candidates interested in running for city offices can contact their city clerk's office for information on obtaining nomination documents.

Does it cost to obtain paperwork for filing for office?

Some but not all offices will require a filing fee in order to run for office.

- Schools and Special Districts will not require a filing fee
- County and State offices will have a filing fee associated with the process of obtaining the proper paperwork

What paperwork will I need to complete?

Some of your paperwork may include:

- **Nomination Petitions**: For offices that require signatures
- Declaration of Candidacy: An official form which states that you are running for an office
- Ballot Designation Worksheet: A form which justifies your title on the ballot
- Candidate Statement (optional): Statement of Qualifications
- Campaign Disclosure Statements:
 Contributions and Expenditure reports filed by a candidate
