Notice is hereby given that Sacramento County Employees' Retirement System (SCERS) will conduct a Member Election during the period of September 23 through October 4, 2019 for the purpose of electing to the Board of Retirement:

## ONE MISCELLANEOUS REPRESENTATIVE

The term of office begins January 1, 2020 and ends December 31, 2022.

**ELIGIBILITY:** Candidates must be an active miscellaneous member of SCERS according to SCERS' records. Only miscellaneous members may be candidates and/or vote for a Miscellaneous Retirement Board Representative.

### CALENDAR OF EVENTS

<b>August 5, 2019, 8 a.m.</b>	First day to obtain candidate nomination papers
<b>August 16, 2019, 5 p.m.</b>	Last day to file candidate nomination papers along with a candidate statement not exceeding 200 words. Pick up nomination papers at Voter Registration and Elections or download at <a href="http://elections.saccounty.net">elections.saccounty.net</a> and return them in person.
<b>September 23 to October 4, 2019</b>	Voting period (by mail ballot); if using hand delivery or inter-office mail, it must be delivered to the Elections Office by 5:00 p.m. on October 4, 2019; if returning by US mail service it must be post marked by October 4, 2019 and received by Elections Office by 5:00 p.m. October 8, 2019.
<b>October 4, 2019, 5 p.m.</b>	Last day to cast ballot/End of Voting Period.
<b>October 11, 2019</b>	Official results released.
<b>January 1, 2020</b>	Term of office begins.

**CANDIDACY INFORMATION:** Pick up and file nomination papers and candidate statement forms at Voter Registration and Elections, 7000 65<sup>th</sup> Street, Suite A, Sacramento, CA 95823, Monday through Friday, from 8 a.m. to 5 p.m. Candidates are requested to pick up and file their nomination papers in person. If a representative is delegated this responsibility, a specific letter of authorization signed by the candidate will be required.

Each candidate is allowed one 200-word statement of qualifications, which will be included in each member's voting material. This statement of qualifications is not verified or corrected by Voter Registration and Elections staff. It will be printed exactly as presented.
