## ONE SAFETY REPRESENTATIVE AND ONE ALTERNATE SAFETY REPRESENTATIVE

The term of office begins January 1, 2025, and ends December 31, 2027.

**ELECTED BOARD MEMBERS:** Safety members of SCERS include employees whose principal duties consist of active law enforcement, or active fire suppression, or who occupy positions designated by law as safety positions. The elected Safety Representative of the Board shall be the safety candidate from either active law enforcement or active fire suppression who receives the highest number of votes from safety members of SCERS. The elected Alternate Safety Representative of the Board shall be the safety candidate who received the highest number of votes who is from the group (law enforcement or fire suppression) not elected as the Safety Representative of the Board. For example, if the elected Safety Representative is from law enforcement, then the candidate from fire suppression with the highest number of votes will be the elected Alternate Safety Representative.

**ELIGIBILITY:** To be eligible to be a candidate or to vote in the election, you must be an active safety member of the Sacramento County Employees' Retirement System according to System records. Only safety members may be candidates and/or vote for a Safety or Alternate Safety Retirement Board Representative.

September 27, 2024, 5 p.m. Last day to cast ballot/End of Voting Period.

October 8, 2024 Official results released.

January 1, 2025 Term of office begins.
