## NOTICE OF INTENTION TO CIRCULATE RECALL PETITIONBY

TO THE HONORABLE **Chris Petersen**: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of The Fair Oaks Water District, Division 1, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Board Member of the Fair Oaks Water District.

The grounds for the recall are as follows:

- Unjustified expenditure of \$10-15 million for maintenance yard renovation.
- Increase in ratepayers' rates by 25% without fair/proper justification.
- Mismanagement and neglect in prioritizing crucial water infrastructure repairs.
- Ignoring the opinions and wishes of the ratepayers in your district/division, whom you represent.

Elections Code section 11023. (a) Within seven days after the filing of the notice of intention, the officer sought to be recalled may file with the elections official, or in the case of a state officer, the Secretary of State, an answer, in not more than 200 words, to the statement of the proponents.

- (b) If an answer is filed, the officer shall, within seven days after the filing of the notice of intention, also serve a copy of it, by personal delivery or by certified mail, on one of the proponents named in the notice of intention.
- (c) The answer shall be signed and shall be accompanied by the printed name and business or residence address of the officer sought to be recalled.
